## **Kratos to Upgrade Es'hailSat's Capacity Management Center for the Es'hail-2 Satellite**

Having deployed the existing CMC for Es'hailSat in 2013, Kratos ISE will expand that system with a monitoring site at the new Es'hailSat teleport, provide the teleport with four new, Kratos-designed earth stations covering the Ku-band and Ka-band mission of the Es'hail-2 satellite, and extend the existing frequency planning system.

Complementing the earth stations Kratos ISE will deploy two of its flagship products: Monics<sup>®</sup> from SAT Corporation, a Kratos subsidiary, is the industry's leading carrier management solution, increasing operational efficiency with real time situational awareness for downlinks and uplinks; and Compass<sup>®</sup> Monitoring & Control (M&C) that improves network resiliency by identifying and resolving equipment issues quickly. Kratos will also provide the CMC with data mining capability to leverage advanced Big Data technology to better manage service levels and optimize satellite operations.

Kratos ISE and Es'hailSat have worked closely together since 2012. "The Kratos team and solutions have proven to be very effective to support our business on Es'hail-1," said Zoubair Kachri, Chief Technical Officer for Es'hailSat. "We look forward to continuing the relationship as we prepare for the launch of Es'hail-2 and our development of Es'hail-3."
