



Kratos Defense & Security Awarded Re-compete Contracts From Defense Contract Management Agency Totaling Approximately \$22 Million

Both contracts have a one year base period and two one-year option periods. The combined total value of the re-compete awards is approximately \$22 million, if all option periods are exercised.

"These two significant contract wins allow Kratos to continue our network engineering, network applications development, and network upgrade and maintenance support to DCMA," said Robin Mickle, president of Kratos Government Solutions, Inc. "Network engineering and network applications development are core capabilities for Kratos, and we are pleased to continue to participate in planning and implementing network improvements for DCMA for the next three years."

Since 2001, Kratos has provided DCMA with network engineering and technical assistance in designing and implementing a web-based enterprise architecture. Today, Kratos operates and hosts a rapid-application development facility that is responsible for full-lifecycle development and deployment of eTools, J2EE-based web-enabled software applications that support the agency's mission. Kratos also provides a range of engineering services which includes Tier 3 services, network software and firmware upgrades, infrastructure installations and video teleconferencing services to support the agency's WAN program.
