

WFI Government Services, Inc. Awarded U.S. Army Contract Valued at Approximately \$25 Million

Primary Work to Focus on White Sands Missile Range

SAN DIEGO, Sept 21, 2005 /PRNewswire-FirstCall via COMTEX/ -- Wireless Facilities, Inc. (WFI) (Nasdaq: WFII), a global leader in the design, deployment, and management of wireless communication networks, technology networks and security systems, announced today that it has been awarded a contract for aerial target related services from the U.S. Army with an approximate value of \$25 million over five years, assuming all option periods are exercised. Under the terms of the contract, WFI will provide a full range of operation and maintenance services for a variety of aerial target systems, including ancillary devices, scoring systems, and command control and tracking systems.

WFI will also provide aerial target flight operations to support air defense training, tri-service test and evaluation, and foreign military sales requirements. These aerial targets will be operated primarily at the White Sands Missile Range and the Fort Bliss McGregor Ranges in New Mexico. As part of the contract, WFI will also deploy personnel, targets, and related equipment to perform flight services at unspecified locations throughout the U.S. and worldwide.

"This is an important and strategic win for WFI. This is one of the largest government contracts that has been awarded to WFI and it further broadens our expertise in the area of target operations and maintenance," said Eric DeMarco, WFI's President and CEO. "This win now positions us as one of the larger providers of aerial target related services for the DoD. We are proud of this distinction and the trust the DoD has in WFI to deliver these services."

"Our presence at the White Sands Missile Range is an important opportunity for WFI to provide technical operations and maintenance on a large, versatile and important national test and training range," said Steven Roth, President of WFI Government Services, Inc. "This contract is a significant achievement in a highly competitive environment and is a further demonstration of the DoD's confidence in the services we provide. Providing aerial target flight operations services gives us the opportunity to deliver strategic and effective solutions for soldier readiness within the defense community and we look forward to further expanding our successful partnership with the U.S. Army."
