

Kratos Defense & Security Solutions Awarded \$15.5 Million in New Business for the Space and Naval Warfare Systems Center San Diego Contract Supporting the Joint Interagency Task Force South

SAN DIEGO, Dec 3, 2007 (PrimeNewswire via COMTEX News Network) -- Kratos Defense and Security Solutions, Inc. (Nasdaq:KTOS) (formerly Wireless Facilities, Inc.) a leading national defense and security solutions provider, announced today that it has been awarded an additional \$15.5 million in new business on its contract with the Space and Naval Warfare Systems Center (SPAWARSYSCEN) San Diego contract supporting the Joint Interagency Task Force (JIATF) South.

Under the contract, Kratos will continue to provide operations and maintenance support, engineering and technical services, computer programming, software support activity services, materials management, and logistics support services for the SPAWARSYSCEN San Diego and the JIATF South C4ISR systems and subsystems in all areas including South American countries, shore sites, land based facilities, shipyards, and on-board ships in port and at sea.

The contract was originally awarded to Kratos in June of 2003, and has a five year base period and eight six-month award terms which, if all option terms are exercised, can extend the life of the contract to 2012. The contract's base period and additional new business award terms have a total value of approximately \$45 million over the life of the contract.

"These new business awards demonstrate Kratos' continued ability to provide an extensive range of engineering and technical support services and resources to the expanding and transforming Naval mission in the Southern Hemisphere," said Eric DeMarco, president and CEO of Kratos Defense & Security Solutions, Inc. "We are privileged to continue our close working relationship with SPAWARSYSCEN San Diego and JIATF South to ensure the best technical capabilities are deployed."
