

Kratos Awarded New \$3.6 Million Department of Education Task Order

SAN DIEGO, Sep 20, 2010 (GlobeNewswire via COMTEX News Network) -- Kratos Defense & Security Solutions, Inc. (Nasdaq:KTOS), a leading National Security Solutions provider, announced today that its Federal Civilian Services team has been awarded a new, three-year task order supporting the Department of Education's (ED) Office of Vocational and Adult Education (OVAE). This task order will aid low-skilled adult workers to transition to employment through career pathways, planned and sequenced courses of study leading to an industry recognized certificate, credential or postsecondary education. Designing Instruction for Career Pathways will provide high quality technical assistance (TA) to state and local adult education providers, enabling them to design and implement career pathways programming to low-skilled adults.

While it is commonly recognized that postsecondary education and training helps workers succeed in the global economy, there are few courses that bridge basic skills instruction with postsecondary opportunities while supporting an adult learner's advancement along career pathways. Kratos will support state and local adult education providers in developing, delivering and disseminating instructional programs that address the educational needs of adult students within multiple career pathway models. This will include providing OVAE with an online vehicle that state and local adult education providers can use to share the materials and resources developed. The contract is expected to be performed over a three-year period, with a total contract value of approximately \$3.6 million.

The project will efficiently leverage previous ED investments to support the transition of low-skilled adults into postsecondary education and employment. Designing Instruction for Career Pathways also supports the broad goals of The American Recovery and Reinvestment Act of 2009 as well as the President's goal for all workers to complete at least a year of postsecondary education or advanced training.

"Our team has a long standing history of supporting the ED's work and we are pleased to have the opportunity to once again demonstrate our commitment to their programs," said Kristine Nowicki, Director of Kratos' Civilian Services team. "We will employ the full range of our learning, communications and technology expertise to achieve ED's goal of providing pathways that prepare participants for the next level of education and employment."
